## MANIPUR STATE PHARMACY COUNCIL-GUIDELINES FOR USING MSPC LOGO (E.C. MEETING Dt. 23<sup>rd</sup> JULY, 2025)

1. The logo of the Manipur State Pharmacy Council established under Section 19 of the Pharmacy Act, 1948 is shown as below:

- The above two logos are the property of the Manipur State Pharmacy Council.
- 3. No body is authorized to reproduce or publish it anywhere without the prior written permission of the Manipur State Pharmacy Council.
- 4. The Pharmacy institutions approved by the Pharmacy council of India under section 12 of the Pharmacy Act, 1948 for running D. Pharm, B. Pharm, B. Pharm(Practice), M. Pharm and Pharm D courses wishing to use the Manipur State Pharmacy Council's two logos, marks, images in promotional, advertising, instructional or reference materials or on their websites, products, labels or packaging shall apply, in writing, for permission of the Manipur State Pharmacy Council in this regard.
- 5. Similarly, the examining authorities of pharmacy courses, the professional pharmacy organizations / associations etc. conducting continuing education programmes for registered pharmacist and / or pharmacy faculty or other professional programmes shall seek prior permission of the Manipur State Pharmacy Council for using its two logos in respect of a particular programme.
- 6. It may be kept in view that the organizations permitted to use, in whole or part, are acknowledging that the Manipur State Pharmacy Council is the sole owner of the two logos including challenging its use, registration of, or application to register such logo, alone or in combination with other images, anywhere in the country and that they will not harm, misuse or bring into disrepute this two logos.
- Except for the limited right to use as expressly permitted, no other rights of any kind, by implication or otherwise, shall be exercised by anyone. The goodwill derived from using the two logos belongs to the Manipur State Pharmacy Council.

## UNAUTHORISED USE OF MSPC LOGO.

- 1. Any use of Manipur State Pharmacy Council's two logos without the prior written permission of the Manipur State Pharmacy Council shall be treated as unauthorized use.
- 2. No one shall use or register, in whole or part, the MSPC's two logos as a part of trade name, product name or service name except as expressly permitted by the Manipur State Pharmacy Council.
- No one shall use or alter the MSPC's two logos as design elements or incorporate them into any other design, graphic or illustration for any purpose.
- 4. No one shall use the MSPC's two logos in a disparaging manner.
- 5. No one shall use the MSPC's two logos in a manner that would imply the MSPC's affiliation with or endorsement, sponsorship or support a third party product or service.
- 6. No one shall manufacture, sell or give-away merchandise items such as T-Shirts, Mugs etc. bearing MSPC's two logos without the express written permission of the Manipur State Pharmacy Council.
